Section 3 - Hazards Identification

Skin Contact - Not hazardous and unlikely to cause any discomfort however the use of gloves is recommended to avoid any temporary staining of the figures and nails.

Inhalation - Fine dust may cause temporary discomfort of the respiratory tract. Repeated or prolonged exposure to the substance can produce target organs damage.

Eye Contact - Avoid eye contact, fine dust may cause irritation /inflammation. Ingestion - Hazardous, if large quantities have been swallowed get medical attention.

Section 4 - First Aid Measures

Skin Contact: Wash off with soap and water.

Inhalation: Remove immediately from area of exposure. If breathing is difficult administer oxygen. Seek medical attention if symptoms persist. Eye Contact: Flush eyes with water for at least 15 minutes.

Ingestion: If large amounts have been ingested seek medical attention
